State law requires every applicant for a license, certificate, registration or other authorization to engage in a business, trade, profession or occupation issued by the Commonwealth to provide a social security number or a control number issued by the Virginia Department of Motor Vehicles.

Instructions on Obtaining Court and Criminal History Records

Certified copies of court records may be obtained by writing to the Clerk of the Court in the jurisdiction in which you were convicted. The address is available from your local police department.

Original criminal history records may be obtained by contacting the state police in the jurisdiction in which you were convicted. Virginia residents must complete a criminal history record request form in the presence of a notary public and mail it to the Department of State Police, Central Criminal Records Exchange, Post Office Box 27472, Midlothian, Virginia 23261-7472.

Applicants with criminal convictions and/or license disciplinary actions will be considered by the Real Estate Board, which requires an additional two to three months of processing and review time.

Activation Requirements

A total of 16 hours of Continuing Education is required to activate a license after 6/30/04. Eight (8) hours in the mandatory topics which include 2 hours in Fair Housing and the remaining 6 hours should include a minimum of 1 hour in each of the following categories: Legal Updates, Real Estate Agency, Real Estate Contracts, and Ethics and Standards of Conduct. The remaining hours may be real estate related or in the specified categories.

Pursuant to Section 54.1-2105(D) of the Code of Virginia, if you were initially licensed as a salesperson after December 31, 2003 you must complete 30 hours of post license education. Failure of a new licensee to complete the 30 hour curriculum within 2 years of obtaining a real estate salesperson's license shall result in non-renewal by the Board of such license until the curriculum has been completed.
